Money: A Drug of Choice

- "For compulsive gamblers, the 'drug of choice' isn't a toxic substance, it's money. Without money to gamble, these people go into withdrawal. Without money, there is no action and without action there is no euphoria or escape. That's why compulsive gamblers will do almost anything to keep the cash and credit flow going."
- "No other addiction poses the kind of financial risk as that
 of a gambling addiction. Drug addicts and alcoholics would
 most likely pass out, overdose or die if they utilized the
 same sums of money to feed their addiction in the same
 period of time as a compulsive gambler."

- Trouble taking personal responsibility
- Trouble developing a sense of personal identity
- Trouble knowing what is enough
- Trouble knowing what is normal for other people
- Trouble learning how to delay gratification
- Trouble giving up status as the constant center of attention
- Trouble becoming competent in everyday skills, self-care skills, and skills for relating with others
